Term Dates 2019/20**Purpose and Recommendation(s)**

The proposed University Academic Calendar for 2019/0 is presented. Senate is asked to APPROVE the proposed term dates for 2019/0.

Paper history

Senate confirmed 2018/9 term dates at its meeting of July 2017 ([SEN/6887](#), [Minute 6905](#) refers). Following the meeting, the date for winter graduation was confirmed as 13 December 2018 and details of when SITS/eVision would be unavailable was also noted to inform operational departments of those dates well in advance ([SEN/6942](#), [Minute 6984](#) February 2018 refers). Draft dates for 2019/0 have been presented to the College Education Committees for information before being presented to Senate and Executive Board for approval.

Background and summary

The University requires its term dates to be published in advance of each academic year to inform applicants and current students as well as all staff.

Term dates

The formal University term dates for 2019/20 for publication on the website are:

Autumn Term: *PGT – 16 September 2019 to 13 December 2019*
 UG – 23 September 2019 to 13 December 2019
Spring Term: *(All) 6 January 2020 to 27 March 2020*
Summer Term: *(All) 20 April 2020 to 10 July 2020*
Term 4: *(All) 13 July 2020 to 18 September 2020*

Enrolment (Week 0)

Induction, Registration and Enrolment week will be 16 September 2019 to 20 September 2019. *Teaching for Postgraduate Taught students will commence from 16 September 2019.*

University closures

Christmas break: Wednesday 25 December 2019 to 1 January 2020 inclusive
Easter break: Wednesday 8 April 2020 to Tuesday 14 April 2020 inclusive

Dates notified to external bodies

The dates to be notified to the Student Loans Company for the 30 week study and assessment period for which student maintenance and fee loans are provided to eligible students (September start), and following current SLC guidelines are:

Term 1: PGT – 16 September 2019 to 13 December 2019
 UG – 23 September 2019 to 13 December 2019
Term 2: (All) 6 January 2020 to 27 March 2020
Term 3: UG – 20 April 2020 to 29 May 2020
 PGT – 20 April 2020 to 31 August 2020

Term dates to be notified to the SLC for postgraduate research students are not shown here as they are dependent on the student's start date, where postgraduate research students are recruited throughout an academic year.

The 52-week programme length to be notified to UKVI for full-time taught postgraduate students requiring a Tier 4 visa extends as follows:

Start date: 16 September 2019
End date: 18 September 2020

Future Academic Year dates

It is proposed that the structure of the academic year undergoes a review, and these proposals will be brought for discussion at Executive Board and Senate in due course.

Issues and options considered

In addition to the above, the schedule of payment due dates and direct debit collection dates has been addressed. Finance has confirmed that those dates are not set until the January of the preceding academic year (i.e. January 2019 for 2019/20) and are only an issue if term dates are changed following approval.

Alignment with contract lengths for accommodation have been considered; however, this particular issue has not been resolved. Contract lengths commence on Sunday 15 September 2019 and are 38 weeks for UG (ending Sunday 7 June 2020) and 51 weeks for PG (ending Sunday 6 September 2020). Postgraduate students would be required to vacate University accommodation two weeks before their course had ended. Further discussion with the Accommodation Office will be required to better align these dates in the future.

In addition, periods during the year when Tier 4 students may and may not work full-time, and how this is notified to the UKVI have been considered. Details are confirmed in the University's [Rights to Work for Students and Clarification on Term Time](#) document, which can be found on the Student Centre Intranet.

Financial implications

Risk assessment/management

Publication of the Academic Calendar mitigates the risk of misinformation to students with consequent recruitment, student satisfaction and contract risks.

Approving term dates for the academic year after next so late in the current academic year has an impact on both admissions and student loans. For applicants deferring entry, offer letters have to be revisited and reissued for confirming the start and end dates of the relevant programme, which are currently left blank. At the time of writing, approximately 350 letters will need to be re-sent. The Student Loans Company require institutions to confirm term dates for the duration of a programme. Up to now, term dates have only applied to undergraduate programmes. However, with the recent introduction of postgraduate loans, with effect from this year, any postgraduate programme starting from 2018/9 has had to include term dates, the details of which normally have to be confirmed by no later than the end of May. For postgraduate programmes starting in January, all relevant term dates span two academic years. In the absence of confirmed dates for 2019/0 an educated guess has been made for dates to be applied to programmes starting in January 2019. As with offer letters, once approved these dates may have to be amended.
