South Korea	<p>Bachelor degree: In a subject related to medicine</p> <p>Year 1 must have a score of at least:</p> <ul style="list-style-type: none"> <li>- GPA 3.2/4, 3.3/4.3 or 3.4/4.5</li> </ul> <p>Or</p> <ul style="list-style-type: none"> <li>- 85%</li> </ul> <p>We do not require you to complete the Bachelor degree, just Year 1</p>

USA	<p>High School Diploma with a minimum GPA of 3.0</p> <p><b>PLUS</b> one of the following:</p> <ul style="list-style-type: none"> <li>• two AP exams with score of 5 in each</li> <li>• two SAT Subject tests with score of 680+ and 680+</li> <li>• one AP exams with score 5 AND one SAT Subject test with score 680+ and 680+</li> </ul> <p>We can also consider Associate Degree with GPA of 3.2 in lieu of high school qualifications.</p> <p>All subject requirements (Chemistry or Biology and second science) should be met through either SAT Subject Tests with scores of 680+ or AP exams with score of 5.</p> <p>For applicants from outside of the US who do not have the High School Diploma but who have taken US qualifications we are able to accept 3 SAT Subject Tests or AP Exams. ## Canada

Entry requirements differ depending on province (please see below table) and in addition Year 12 must include either Chemistry or Biology, and a second science (Chemistry, Biology, Physics or Mathematics)

British Columbia	<p>British Columbia Senior Secondary Graduation Diploma with 80% in at least five acceptable grade 12 subjects</p> <p>*Subject requirements must be met at 80%</p>

Manitoba	<p>High School Graduation Diploma with 80% in five grade 12 courses, marked 40S or 40G</p> <p>*Subject requirements should be met at 80%</p> <p>NB Grade 11 Secondary School Diploma is too low</p>
New Brunswick	<p>High School Graduation Diploma with a minimum of 80% in five grade 12 courses, marked 120, 121 or 122</p> <p>*Subject requirements should be met at 80%</p>
Alberta; Newfoundland and Labrador; North West Territories; Nunavut; Prince Edward Island; Saskatchewan; Nova Scotia	<p>Graduate Certificate with minimum of 80% in five grade 12 courses, marked 30 or 31</p> <p>*Subject requirements should be met at 80%</p>
